I, THE ADOPTER, REPRESENT THAT THE INFORMATION PROVIDED IN THE APPLICATION PROCESS IS TRUE AND CORRECT TO THE BEST OF MY INFORMATION AND BELIEF. I AGREE TO ADOPT THE KITTEN FROM BREEDER AND AGREE TO ALL OF THE FOLLOWING CONDITIONS.

Please Initial each line indicating you have read and accept the terms of this Agreement.

_____ I agree to provide the kitten clean water, high-quality food, adequate shelter and kind treatment at all times.

_____ I agree to provide regular wellness veterinarian examinations including recommended immunizations as well as necessary care in the event of illness or injury.

_____ **I agree to have the kitten spayed or neutered by the date specified herein. I understand failure to provide veterinarian documentation of spay/neuter to Breeder by the required date will be deemed a material breach of this agreement and the kitten will be returned to breeder with no compensation to Adopter. In the event the kitten/cat produces a litter, the Breeder will take possession of the litter as well as the adopted kitten. Spay/Neuter required no later than _____ and veterinarian proof provided to Breeder within three days of procedure. Registration papers for kitten will be provided to Adopter once this condition is met.**

_____ I agree Breeder may use any photographs/videos of my kitten that I share with Breeder on Breeder's web/social media pages.

_____ I agree to license the kitten in compliance with the laws and ordinances in force where I reside.

_____ I agree I will not allow the kitten to be used for medical or experimental purposes.

_____ I agree to notify Breeder if I decide at any time that I cannot keep the kitten and will not surrender the kitten to a shelter or abandon the kitten without first making every attempt to notify Breeder. **I understand that if I dispose of the kitten in a manner not in compliance with this paragraph, it constitutes a material breach of this agreement.** I understand that returning the kitten to Breeder may take 1 to 2 weeks and that I am responsible for costs associated with boarding the kitten in the interim. Breeder will work with adopter to find a suitable home for the kitten/cat.

_____ I agree to take the kitten to be examined by a licensed veterinarian within 72 hours (excluding weekends and holidays) of receiving the kitten. **I understand that failure to do so will make the genetic health guarantee null and void.** If any abnormalities are found, I will provide Breeder the written report from the licensed veterinarian immediately.

Full Agreement: This Agreement sets forth the entire Agreement between the Parties and fully supersedes any and all prior conversations, agreements, or understandings between the Parties pertaining to the kitten. This Agreement may only be modified by a written notice of change by Breeder.
